### CONDITIONS FOR GRANTING AFFILIATION

1. The right to grant affiliation to a Society is vested with the Regional Council of the Federation.
2. The decision of the Regional Council will be communicated to the Society immediately after the first Council meeting following receipt of application.
3. If the Council decides to grant affiliation , the matter will be conveyed to the society, and the Society has to remit the annual subscription to the Federation( at the rate of Rs.4/- per member of the Society, subject to a minimum of Rs.500/-) by way of demand draft in favour of Federation of Film Societies of India payable at Thiruvananthapuram, within one month of receipt of such communication
4. The annual subscription once paid will be for the calendar year April to March.
5. If a Society does not remit its subscription within one month of receipt of communication granting affiliation, the application will be lodged at our end. In such case, the affiliation is not refundable.
6. The Regional Council reserves the right not to grant affiliation to any society, to cancel the affiliation once granted, or to disaffiliate any Society if deemed warranted.
7. The activities of the newly formed Society should not be a hindrance to any other affiliated Society of that area.
